PLEASE READ THESE TERMS AND CONDITIONS CAREFULLY BEFORE USING THIS SITE

This website, (our site), is owned and operated by Train4Academy Limited, also referred to as “we”, “our”, and/or “us”. This acceptable use policy sets out the terms between you and us under which you may access this website (our site). This Acceptable Use policy applies to all users of, and visitors to, our site.

- Be likely to harass, upset, embarrass, alarm or annoy any other person.
- Be used to impersonate any person, or to misrepresent your identity or affiliation with any person.
- Give the impression that they emanate from us, if this is not the case.

- Advocate, promote or assist any unlawful act such as (by way of example only) copyright infringement or computer misuse.

SUSPENSION AND TERMINATION

We will determine, in our discretion, whether there has been a breach of this Acceptable Use policy through your use of our site. When a breach of this policy has occurred, we may take such action as we deem appropriate.
